

# ALLEGATO AL D.R.

#### **The Rector**

**Given** articles 1, paragraph 4, and 2, paragraph 4, of the University Statute; **Given** Article 5, paragraph 1, of the University Statute, by which the University guarantees "freedom and autonomy [...] in the organization and conduct of research and training activities [...] in observance of the principles of freedom and human dignity, peaceful coexistence among peoples";

**Given** the exceptional difficulties that Ukrainian students and teachers are experiencing as a result of the current emergency situation in Ukraine; **Given** the letter of the Ministry of University and Research of 27/02/2022 (Reg. U.0003177. 27-02-2022), in which it is highlighted that the Ministry is working to "promote concrete actions that will lead rapidly to the reception of Ukrainian students, researchers and professors in our Universities, Research Institutions, and Institutions of higher artistic, musical and dance education" and therefore requires to report "any form of willingness to receive and host Ukrainian students, teachers and researchers, in terms of scholarships and accommodation";

**Considering that** the University of Perugia has for many years had close and fruitful relations of international cooperation with Ukrainian universities, including the Danylo Halytsky Lviv National Medical University, the Ivan Franko National University of Lviv, the Lviv Politechnic National University and the Ukrainian Academy of Banking of the National Bank of Ukraine, as part of both mobility agreements for students, teachers and researchers, and agreements for the achievement of a double degree;

**Considering** it appropriate to make available resources for the reception of students, professors and researchers through a call for incoming mobility grants for students, professors and researchers from Ukrainian Universities and Research Institutions;

**Given** the resolution of the Board of Governors of 31/03/2022 with which the provision was approved of incoming mobility contributions for students, professors and researchers through the issuance of a call for the reception of students, professors and researchers from Ukrainian Universities and Research Institutions;

## Decrees

## Article 1

A public call is issued for the provision of incoming mobility grants for students, professors and researchers from Ukrainian Universities and Research Institutions to the University of Perugia, as specified below:

a) 40 study mobility grants for students, each of the monthly amount of Euro 450.00 for the duration of 5 (five) months;

b) 10 mobility grants for teaching and research activities for teachers and researchers, each of the monthly amount of € 1,250.00 for the duration of 5 (five) months, upon assignment to the University facility relevant to the disciplinary profile of the teacher / researcher.

The scholarships referred to in letters a) and b) are paid upon the arrival of the selected candidates in Italy.

# Article 2 - Application procedures for candidates

The application must be submitted exclusively through the on-line form available at the link https://www.unipg.it/internazionale/bandi-e-news by 12.00 noon on May 23, 2022.

In the event that, after this date, grants are not awarded, the terms of submission of the application will be reopened, with the procedure stated above. The application will be evaluated, selected and eventually accepted until all mobility grants are awarded.



### Article 3 - Selection process

The evaluation and selection of applications will be carried out by a specific Commission appointed by Rector's Decree.

The selection will take into account the coherence and compatibility of the previous course of studies of the students with the specific educational offer of the University of Perugia, the disciplinary profile of the teachers and researchers candidates and the chronological order in which applications are received.

## Article 4 - Processing of personal data

The processing of personal data required by this call is carried out exclusively for all activities strictly functional to the procedure, for the execution of a task related to the exercise of public powers of which the University of Perugia is invested, as owner of the treatment.
