TRANSLATION OF THE DECREE no. 1679 of October 20, 2017

Extension of the deadline for the submittal of documentation listed in art. 2 and in the Call for Applications for the admission in PhD Courses – XXXIII Cycle – A.Y. 2017/2018 (D.R. 1143 issued on 24.7.2017)

The Rector

Considering the Regulations of PhD courses of the Università degli Studi di Perugia, issued by D.R. no. 1548 of 7.8.2013, and more specifically art. 18;

Considering D.R. no. 1143 of 24.7.2017, published on 25.7.2017, that, following a request by the Coordinators of PhD courses, made in compliance with the regulations, issued the Call for Applications for the public selection aimed at admission to PhD courses – XXXIII Cycle – A.Y. 2017/2018, with established legal residence at the Università degli Studi di Perugia;

Considering articles 2 and 3 of the aforementioned D.R. 1143, stating that candidates who have obtained their academic qualification after 28.08.2017 and within 31.10.2017, as well as candidates holding a foreign academic qualification, were required to submit the pertinent documentation within November 16, 2017;

Considering the notifications that have been received from some of the candidates holding foreign academic qualifications, informing us that they have experienced several issues when trying to obtain the required documents (as per D.R. no. 1143/2017) from the pertinent Consular/Diplomatic bodies, the deadline for submitting these documents having being set on November 16, 2017;

Deeming it appropriate to extend the aforementioned deadline, not later than 15.12.2017, to help candidates who will submit documented requests for the authorization for the late submittal of the aforementioned documentation, that is to say after the original deadline set on November 16, 2017 and within December 15, 2017, duly describing the concrete difficulties in obtaining the required documents, thus excluding those cases in which the late submittal is a direct consequence of the candidate's behavior;

HEREBY DECREES Art.1

The original deadline for the submittal of the documentation required as per D.R. no. 1143/2017 for the declaration of equivalency of academic qualifications, originally set on November 16, 2017, can be extended within December 15, 2017 for candidates who will document their actual difficulties in obtaining the required documentation, except for those cases in which said difficulty is due to the candidate's behavior;
